#### **Processing**

Semiconducting **SP-PESC-566** has been formulated to be easily extrudable using conventional polyethylene extrusion lines. For optimum extrusion result with SP-PESC-566 use melt extrusion temperature in the range of 180 - 220°C. Specific processing condition can be determined only by trials on individual equipment.

Semiconducting SP-PESC-566 absorbs moisture which can result in porosity in the extrudate. It is therefore recommended that the compound be thoroughly dried prior to use, usually 2-4 hours in hopper drier at 70 -75 °C.

#### **Shipment**

**SP-PESC-566** is available in the form of free flowing pellets and supplied in bags of moisture resistant material with a net content of 25 Kg.

Material also available in Jumbo Boxes with a net content of 600 Kgs.

## Storage & shelf life

The product/compound should remain in

- Sealed condition
- Without exposing to direct sunlight and temperature not exceeding 45°C

Shelf life of the compound is 12 months from the date of manufacture.

Product alteration may occur due to extended period of storage.

## Safety

**SP-PESC-566** is not classified as a dangerous preparation.

The product is supplied in form of pellets of about 2-3 mm in size and can be readily handled with commercially available equipment. All handling and transport of the product may generate some dust and fines, which constitute a potential risk for dust explosion. Therefore, all instruments in the system should be properly grounded. Properly designed equipment and good storage will reduce the potential risk. Please, check and follow local disposal regulations!
