# Packaging

**SPL-VTEK-606T** is available in the form of free flowing pellets and supplied in bags of moisture resistant material with a net content of 30 Kgs. Material also available in Jumbo bags with a net content of 900 Kgs.

### Storage & shelf life

The product/compound should remain in

- Sealed condition
- Without exposing to direct sunlight and temperature not exceeding 45°C
- Shelf life of the compound is 12 months from the date of manufacture.

Product alteration may occur due to extended period of storage.

### Safety

**SPL-VTEK-606T** is not classified as a dangerous preparation.

The product is supplied in form of pellets of about 3 – 4 mm in size and can be readily handled with commercially available equipment.
