PROCESSING TECHNIQUES

SPL-FRLS-31 RoHS can be processed on any good extruder designed for PVC at temperatures in the range of 140°C-180°C. The screw must have a good homogenizing capacity.

SPL-FRLS-31 RoHS is available in the form of free flowing pellets and supplied in bags of moisture resistant material with a net content of 30 Kgs. Material also available in Jumbo Boxes with a net content of 900 Kgs.

STORAGE & SHELF LIFE
